



## WHAT DO I NEED TO SHOW FOR PROOF OF VACCINATION?

Where vaccine passports are required, community members will need a valid vaccine passport (contains QR code) AND identification if 19+ years of age (1 photo ID with name and date of birth, or 2 IDs with name and date of birth on at least one).

## WHEN DO I NEED TO SHOW PROOF OF VACCINATION?

Some general guidelines have been provided below for all First Light facilities, with more information on specific locations provided on page 2.

### GROUP PROGRAMS

### YOUTH UNDER 18

Vaccine passport **IS REQUIRED** when attending any group program, drop-in or otherwise.

Vaccine passport **IS NOT REQUIRED** when attending any group program, drop-in or otherwise.

### OFFICE BUILDINGS

Vaccine passport **IS NOT REQUIRED** to access an office building.

Vaccine passport **IS REQUIRED** if a gathering is hosted in a meeting room in an office building.

## WHAT IF I HAVE A MEDICAL EXEMPTION?

Community members who have received a medical exemption approved by a physician will still have a Vaccination Passport. They will have a green bar visible on their vaccination passport, and their QR will be scannable and accepted by the NLVaxVerify App.

## WHAT IF I DON'T HAVE AN NL COVID PASSPORT?

People who are visiting from outside the province, or those without a vaccination passport can have their vaccination status confirmed by showing proof of vaccination and identification.

## WHAT ARE THE SPECIFIC RULES FOR EACH LOCATION?

### 716 WATER STREET

Proof of vaccination is **NOT REQUIRED** to enter the property to request support/services.

Proof of vaccination is **NOT REQUIRED** for individual support, as this is considered an essential service.

Proof of vaccination **IS REQUIRED** when attending any group program, drop-in or otherwise. This includes Toast & Tea, Men's Group, and all other community programming.

### 42 BANNERMAN/81 COCHRANE (PERFORMANCE CENTRE)

Proof of vaccination **IS REQUIRED** for all venue guests and artists (ages 12+) when attending all group events, gatherings & programs.

### 97 ELIZABETH AVENUE (CHILDCARE CENTRE)

Parents/Guardians are **NOT REQUIRED** to show proof of vaccination as per provincial guidelines.

### 40 QUIDI VIDI ROAD

Proof of vaccination is **NOT REQUIRED** to enter the property to request support/services.

Parents who are dropping off youth at an afterschool program are **NOT REQUIRED** to show proof of vaccination.

Proof of vaccination **IS REQUIRED** when attending any group program.

### 36 QUIDI VIDI ROAD (MEDICAL TRANSPORTATION)

Proof of vaccination is **NOT REQUIRED** to access medical transportation services.
